NOTES:

1. You must pay an amount of Income Tax and/or Capital Gains Tax for each tax year (6th April to 5th April) that is at least equal to the amount of tax that all the charities or Community Amateur Sports Clubs (CASCs) that you donate to will reclaim on your gifts for that tax year. Other taxes such as VAT and Council Tax do not qualify.
2. You can cancel this declaration at any time by notifying St. Mary's.
3. You must pay an amount of income tax and/or capital gains tax at least equal to the tax that St. Mary's Church reclaims on your donations in the tax year (currently 25p for each £1 you give).
4. If in the future your circumstances change and you no longer pay tax on your income or capital gains equal to the tax that St. Mary's reclaims, you can cancel your declaration (see note 1).
5. If you pay tax at the higher rate, you could claim tax relief in your self-assessment tax return.
6. If you are unsure whether your donations qualify for Gift Aid tax relief you should speak to St. Mary's Church or ask your local tax office for leaflet IR65 Gift Aid.
